


Summary Record of the Pre bid Meeting of NIT held on 19th July, 2017 under the Chairmanship of Shri R.C.Aggarwal, Deputy Director General (RCA)

A Meeting for prospective bidders for Evaluation of Central Sector Scheme for Conservation Development and Sustainable Management of Medicinal Plants (CDSMMP), NMPB, Ministry of AYUSH and a pilot study on AYUSH Components namely Ayurveda, Homoeopathy and Unani in National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases & Stroke (NPCDCS) in collaboration with Directorate General of Health Services, Ministry of Health and Family Welfare was held on 19th July, 2017 in the Committee Room, Ministry of AYUSH, AYUSH Bhawan, INA, Delhi-110023 regarding NIT, where Members of screening committee were also present and DDG (RCA) presided the meeting .

2. The list of participants is at Annexure-I.
3. At the outset, DDG (RCA) welcomed all participants and initiated discussion by highlighting the objectives of the NIT.
3. One prospective bidder raised question regarding the relaxation for 3 evaluation studies in the last 5 years in Govt. Sector. On this Chairman clarified that this condition is mandatory and cannot be relaxed.
4. In the meeting some questions were raised on technical part of the study of the NIT which were clarified by the members of the Committee.
5. It was also cleared in the meeting that agency should communicate with the beneficiary and the AYUSH person in each CHCs during evaluation for NPCDCS.
5. Part of discussion was also held on the methodology of collecting samples for the study.
6. It was further clarified that EMD is Rs. 2,00,000/- in words also which was inadvertently written as Rs five lakhs instead of Rs two lakhs on Pg. No. 10 in point 12 of NIT.
7. The meeting ended with the vote of thanks to the Chair.
